

ADVERTISEMENT FOR BIDS

Sealed bids will be received at the offices of the Board of County Commissioners, Allen County, Ohio, Courthouse Room 300, until **11:00 a.m., (local time) on Thursday, August 21, 2008** for completing the **BUS GARAGE SITE IMPROVEMENTS, Allen County Board of Mental Retardation and Developmental Disabilities**, at which time they will be opened and publicly read.

Pursuant to Section 307.87, said advertisement for bids will be posted on the contracting authority's internet site at www.allencountyohio.com and accessed by clicking bid openings. The advertisement for bids will also be posted at www.acbmrdd.org and accessed by clicking advertisement for bids.

The project site is located at 2500 Ada Road; Lima, Ohio. The proposed work consists of paving various areas as shown on the Drawings. Items of work include 2026 sy of 7" concrete pavement with reinforcement, 104 cy asphalt intermediate course, 74 cy of asphalt surface course, 75 lf 12" Type B storm conduit, 124 lf 10" Type B storm conduit, 220 lf 4" pipe underdrain, pavement striping, seeding, and all related items as shown in the Contract Documents and called for on the Proposal for Unit Price Contract.

A non-refundable payment of **Thirty (\$30.00) Dollars** will be required for each set of Contract Documents taken from the above office. Checks shall be made **payable to Kohli & Kaliher Associates, Inc.**

Each bid shall contain the full name of each person or company interested and shall be accompanied by a bond or certified check made payable to the Board of Allen County Commissioners, equal to at least ten (10%) percent of the bid upon the condition that if the bid is accepted, a contract will be entered into within ten (10) days. A performance bond of one hundred (100%) percent of the amount of the contract, with satisfactory corporate sureties, will be required for the faithful performance of the work.

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as determined by the Ohio Department of Commerce, Bureau of Wage and Hour.

Bids shall be sealed and endorsed **BUS GARAGE SITE IMPROVEMENTS, Allen County Board of Mental Retardation and Developmental Disabilities**, and addressed to the Board of Allen County Commissioners. No proposal will be entertained unless made on the blanks attached to the bound documents furnished by the Board of Allen County Commissioners and designated for taking bids for this Project.

The bidder's attention is called to the necessity of starting the work at once upon written Notice to Proceed. All work shall be completed by **November 15, 2008**. No bidder shall be permitted to withdraw his bid for a period of thirty (30) days after the time of opening bids.

The Board of Allen County Commissioners reserves the right to accept or reject all proposals or to waive all informalities or irregularities in the bidding. This Contract will be awarded based on the lowest and best bid or the lowest responsible bid as approved by law.
